Scott Corporation Limited Dividend Reinvestment Plan

Scott Corporation Limited wishes to confirm that the Dividend Reinvestment Plan (“DRP”) will apply in respect of the fully franked final dividend for 2008 of 1 cent per share announced on 28 August 2008.

The terms of the DRP is based on information sourced from the Australian Stock Exchange Research Service, indicating the weighted average of the ASX market prices of Scott Corporation Limited shares on the five trading days immediately following the record date of 26 September 2008 less a 5% discount as set by the Directors. The effective payment date for the final dividend will be 10 October 2008.

The shares issued under the DRP are fully paid up ordinary shares in Scott Corporation Limited and will rank equally with existing ordinary shares.
